Theater Arts Booster Club Use of Photos on the Theatre Web Site

The MRHS Theatre Arts Booster Club maintains a web site where information about the theatre program and booster club is posted, as well as pictures from past productions of the Maverick Theatre Company.

In order to post pictures of a student, we need permission from their legal guardian. Which is the purpose of this letter and the attached form.

There is a good chance that if your child participates in any theatre activities, we will have a picture of them. Signing the form does not guarantee that photos of your student will be posted....it simply gives permission to use photos we receive, if your student is in one of them.

All pictures posted are reviewed to be sure they are supportive of the Theatre department.

Most of the pictures placed on the website will be reduced in size and quality. Names of students will NEVER be placed by pictures, and personal information (age, address, etc.) about students will never be posted. Most pictures posted on the Internet are group shots of students in scenes or rehearsals of productions. The majority of the viewers of our website are the parents and students involved in our program, as well as educators curious about our program.

Our goal is 100% return of permission forms, so we do not have to exclude photos because we do not have permission forms for all of the students in a picture.
